

**2008 APPLICATION FOR SEALED BID
ON 2008 RANGER Z-20 AND 225 YAMAHA HPDI MOTOR**

Members of the Georgia Bass Federation will be given an opportunity to place a sealed bid on a 2008 Ranger Z-20, Dual Axle Trailer, and a 2008 Yamaha 225 HPDI (series 2) Motor. The successful bidder will be the qualified GBCF/TBF/FLW member that sends in the HIGHEST BID.

The Boat is equipped with Dual Axle Trailer, 2 – X-135 Lowrance units, 24 volt 80 lb Max Pro Minn Kota Trolling Motor, Recessed Trolling Motor foot pedal, Hot Foot, 10” Jack plate, Trim Lever, Remote Oil Fill, Retractable Rod Buckles, Front Deck Step, Boarding ladder.

Bids will be accepted starting Monday, April 14, 2008 and the Bids will be opened on Saturday, May 31, 2008 at HD Marine in Buford, Georgia at 10:00 am. The Bids will be opened by the Georgia Bass Federation Officers. Anyone submitting a Bid may be present if they desire.

RULES OF THE BID

1. Bidder must be an Active (paid) member of a GBCF Club, TBF and FLW to submit a bid.
2. Bids that are mailed must be received by Thursday, May 29, 2008.
3. Hand carried Bids to HD Marine will be accepted by 9:30 am, May 31, 2008.
4. The bid must be the Application form posted on the GBCF website (www.gabassfed.org) and must be completely filled out.
5. A \$500.00 check payable to GBCF and self-addressed, stamped envelope must be included with all bids. Put “Boat Bid” at bottom of check.
6. In case of ties, bids with the earliest Postmark will be the winner. If the bids are stilled tied after review of the postmark, a flip of a coin will determine the winner.
7. Checks of unsuccessful bidders will be returned.
8. If you are the successful bidder and decide NOT to exercise your right to purchase the Boat, your check for \$500.00 will be forfeited and the next highest bid will be considered.
9. The successful bidder will have two (2) weeks from the date of the opening of the bids, to send a certified Cashiers check for the amount of the full bid. Your \$ 500 check will be returned.
